2025 Parent Agreement Addendum

The purpose of this addendum is to provide **formal confirmation** of the following:
Section 1:

1. This addendum aims to officially acknowledge the adjustments made to the financial arrangement for the 2024 programme year extending to 2025
2. Any outstanding balances from the 2024 fees have been incorporated into the financial plan for the 2025 period.
3. This addendum is an essential part of the original player/parent agreement from 2024, encompassing all its associated terms and conditions.
4. Please note the following in amendments with regards to the cancellation policy:

Cancellation Policy:

1. A notice period of 20 (twenty) business days, after the Financial Agreement is signed, must be adhered to. A cancellation penalty of R5,500 (five thousand five hundred rand) will become payable.
2. The cancellation policy is applicable starting January 1, 2025, for the contractual addendum.

- 2.1. A non-refundable registration/application fee of R2,000.
- 2.2. A non-refundable kit fee of R5,500, payable once the order has been placed.
- 2.3. An annual subscription fee of R2,750 for the A Game Athlete mental program.
- 2.4. The cumulative monthly repayment fee at the time of cancellation, as stipulated in Section A of the financial agreement.
- 2.5. All arrears amounts and cancellation fees are payable within 7 days to finalize the cancellation.

- 2.6. Forfeiture of any allocated educational and rugby bursaries, with liability for the full cost of the programs.
 - 2.7. Forfeiture of the accommodation deposit, whether with internal or external third-party providers.
 - 2.8. Payment of the monthly accommodation fee for the period of accommodation.
3. No cancellation is applicable after the 1st of June of the Sport/Academic development year and any funds in credit can only be utilised towards an academic program from the UXi listed providers.
 4. No cancellation is applicable to injuries associated with the sport and or not, and any funds in credit can only be utilised towards an academic qualification from the UXi listed providers.
 5. Should a credit be in favour of the Player and/or the Parent/Guardian/Sponsor, it will be refunded to such Player and/or Parent/Guardian/Sponsor on completion of the Refund documentation. Should there be a debit, the Player and/or Parent/Guardian/Sponsor will be liable to pay such debit as stipulated in Section B.1 and B.2 as well as the cancellation schedule outlined in Section B.2(2.1-2.10) and the Player Agreement.
 6. Cancellation requests should be submitted in writing stipulating the reasons in detail and be accompanied by supporting documents. All cancellations will be reviewed, and the outcome will be confirmed in writing.
 7. In the event of the Player, Parent/Guardian/Sponsor cancelling their Agreement, the Player, Parent/Guardian/Sponsor will be refunded the stipulated monies after a period of 30 days, from receipt of the completed refund application form.
 8. No Player shall be released to another Rugby Union, affiliated clubs, both national and international, until all financial agreement amounts in respect of the cancellation policy have been paid in full. Should the Player be offered opportunities whilst in the program from other unions, universities, clubs or organisations related to the sport, the agreement must remain honoured for its full duration and or can be bought out by such parties.
 9. In the event of the Player, Parent/Guardian/Sponsor cancelling their Agreement, the Player will forfeit the appointed education partner bursary/discount awarded to him that forms part of a formal agreement with Education partners for UXi Rugby Institute registers as prescribed in the bursary price list provided.

10. In the event that a player has received a bursary or partial Rugby development bursary- the player will forfeit such bursary on cancellation and or default and the full cost for the program becomes applicable.
11. In the event of a 24-month Agreement being cancelled prior to the Agreement reaching a minimum term period of 12 months, the Agreement will automatically default to the 12-month investment option payment plan. All discounted rates applicable to 24-month Agreements will then be forfeited.
12. In the event of financial default, cancellation of debit orders or loss of employment, UXi Rugby Institutes retain the right to recover all outstanding amounts from the principal debtor as stipulated in Section A of the original Agreement and as outlined in Section B 2 (2.1-2.10) of this agreement.
13. We undertake to pay all fees punctually as mentioned in the original Parent/Guardian/Sponsor Financial Agreement on the agreed dates and that administration costs on arrear collections will be debited to my/our account.
14. That we have read and fully understand the amended Cancellation clause of the original agreement.
